

Wyggestons and Trinity Almshouses Charity - Self-assessment form 2024.

This self-assessment form has been completed by the Complaints Officer and it must be reviewed and approved by the Charity's governing body at least annually.

Once approved, landlords must publish the self-assessment as part of the annual complaints performance and service improvement report on their website. The governing body's response to the report must be published alongside this.

Landlords are required to complete the self-assessment in full and support all statements with evidence, with additional commentary as necessary.
